-New starting blocks for the VHE pool are needed; TL is waiting on a quote

-Boys and Girls XC is due for uniforms in the fall; looking for a singlet and warm-up jackets

-TL waiting on better financial info from the LAX co-op before making a decision on the SHS financial contribution; LAX will be treated like all other co-ops

6. <u>SHS Athlete Signing Day</u>

-Event went well; lots of students attended due to the earlier start time -SBC refreshment contribution was appreciated

7. Individual Team Request Protocol/Policy

-Board voted via email to adopt a 50/50 split for athlete reimbursement only for the Track and field request

-Board discussed the idea of providing a hat to state qualifiers for next school year; topic to be discussed in more depth at the August meeting

8. <u>Membership Report by Ryan Vanderloop</u>

-No new memberships since our last meeting

-RV will need to update Infinite Campus by 7/1/24 with the new memberships levels for the next school year
